Dear Heath School Family,

Welcome to the Heath School! As your family prepares for your child to enter a higher grade at the Heath School, Extended Day is planning for the 2008-2009 school year. Heath Extended Day is a non-profit organization that provides exciting after-school enrichment activities to children in pre-kindergarten through grade eight regardless of race, sex, religion, cultural heritage, political beliefs, disabilities, or marital status. We aim to accommodate families who need a safe educational after-school setting that coordinates with each family's busy schedule.

The Heath Extended Day Program is committed to providing high quality childcare for the Heath community. The objective of our program is to contribute to the social, emotional, and cognitive growth of children in an environment that is safe and nurturing. The curriculum is developed by our programs professional staff and seeks to incorporate each child's interests as well as foster the growth of each individual child. Through activities that are enjoyable and enriching, Heath Extended Day seeks opportunities for exploring individual interests, educational enhancement, developing independence & self confidence, and enjoying and forming relationships.

Current Heath Extended Day families Pre-Registration forms will be accepted through March 31st 2008 on a first come first serve basis. In order to assure your child a space in our program it is advisable to complete the attached registration form. A non-refundable registration fee of \$40.00 for your first child, (proceeding with a \$10.00 discount for each additional sibling) must accompany the registration form in order to be processed. Tuition rates for the current school year can be found on the attached application and may be subject to change.

A confirmation and acceptance letter will be sent to each family accepted into the program by April 25th 2008 . The contract will confirm the number of days your child(ren) will be enrolled in Heath Extended Day, the tuition amount, and deposit due. A deposit of one month's tuition must be paid to the Heath Extended Day Program by May 30th 2008 in order to secure a space. This deposit will be applied to the tuition for your child's last month at Heath Extended Day for the contracted year. Families who are not accepted into our Program will be notified in writing. These families will be placed on a waiting list and contacted when a space becomes available.
